Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 Performa were examined by the Medical Assessment and Rating Board.

On careful scrutiny and examination of the report, the Medical Assessment and Rating Board has observed the following shortfall:

- Form 16 not from Traces Portal

2. After considering the provisions of NCH Act, 2020 and its relevant regulations, **permission of the Medical Assessment and Rating Board is issued to Agarwal Education Foundation, S.S. Agarwal Homoeopathic Medical College Near Devina Park Society, Viranjali Marg, Gandevi Raod, Navsari Gujarat for UG (BHMS) course with intake capacity of 100 seats**. The Principal is directed to fulfill the deficiencies within three months and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.

3. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET). Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. College need to fulfill all requirements as per NCH Act 2020 and relevant regulations. All shortfalls shall be rectified within period of one month from 30 days of issue of permission of this letter

4 The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder

5 The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.


